## **About the Pathway**

This pathway meets requirements for the Associate of Business -DTA (AB-DTA) with an emphasis in Economics. Completion of this degree opens doors to a variety of careers in sectors including non-profit, business, government, finance, and education. It also allows you to transfer at the junior level into a Economics program at a four-year college or university.

Students learn a unique way of thinking about the problems, decisions and outcomes that people, businesses and governments incur through the lens of economics. Topics include markets and prices, consumer behavior, employment, inflation, international trade, and government policy. Students in this pathway develop skills in data analysis, critical thinking, quantitative and qualitative research, verbal communication, group communication and collaboration, and leadership and facilitation. Competencies in these areas consistently rank at the top of employer wish lists.

## **Length of Program**

90 credits = 9 quarters if you take 10 credits\* each term.

\*Students who take 15 credits each quarter earn their degree faster, qualify for more financial aid, and earn more money over their lifetime because they complete their schooling faster.

## **Future Education Opportunities**

Once you complete the AB-DTA degree, additional education opportunities include:

- A Bachelor's degree in Economics, Business, Finance, Data Analytics, or a related field at a four-year college or university.
- A Bachelor of Applied Science (BAS) degree in Accounting in International Accounting, International Business, and Residential & Commercial Property Management at North Seattle College.

North Seattle College has direct transfer agreements with four-year institutions throughout Washington state, including the University of Washington, Washington State University, and Seattle University. Communication Studies graduates from North have also transferred to out-of-state institutions.

Program and admissions requirements vary from college-to-college. It is recommended that students explore programming opportunities such as R and Python, and upper level math/statistics. Contact an advisor to create an educational plan tailored to transfer to the institution of your choice.
