## Commendations

The Commission commends North Seattle College for:

- 1. Its student-centered approach, including the creation of a sense of belonging for students, its creativity in providing wholistic student support, and the repurposing of facilities to create inviting and unique student support spaces.
- 2. Its commitment to equity, diversity, inclusion, and community. It is clear that this work is central to how the institution approaches student support and student success.
- 3. The faculty energy and commitment devoted to improving teaching and learning practices through TIPs, ongoing program review, and peer learning and support opportunities.
- 4. Its commitment to strategically pursuing and implementing grants in a manner that allows the college to develop, test, and implement strategies to improve student support services and student learning opportunities.

# Recommendations Substantially in Compliance but in Need of Improvement

The Commission recommends that North Seattle College:

- Recommendation 1: Spring 2023 Evaluation of Institutional Effectiveness Develop and implement an ongoing and systematic evaluation and planning process to inform decision making, allocate resources, and improve student learning and student achievement. (2020 Standard(s) 1.B.1)
- Recommendation 2: Spring 2023 Evaluation of Institutional Effectiveness Make use of assessment of student learning outcomes at the program and institutional levels to generate measurable and meaningful data that informs academic planning and continuous improvement processes. (2020 Standard(s) 1.C.7)
- Recommendation 3: Spring 2023 Evaluation of Institutional Effectiveness Establish and share widely, including on the institution's public facing website, a set of institutionally identified indicators for student achievement including, but not limited to, persistence, completion, retention, and postgraduation success. These indicators should be appropriately disaggregated and benchmarked against indicators for regional and national peer institutions. (2020 Standard(s) 1.D.2;1.D.3)
- Recommendation 4: Spring 2023 Evaluation of Institutional Effectiveness Establish clear decisionmaking structures and processes, both at the college and between the college and district, which are documented and publicly available, and include provisions for the consideration of the views of faculty, staff, administrators, and students on matters in which each has a direct and reasonable interest. (2020 Standard(s) 2.A.4)
