REQUIRED COURSES:

ADMISSION APPLICATION:

The Foster School of Business admits students for autumn and winter quarters. Students admitted for autumn quarter have the option to enroll in summer quarter.

Students applying to UW's Foster School of Business must complete two applications:

1. UW application for general admission
2. The Foster School of Business application

Applicants not admitted for general admission will not be admitted to the Business School. The Foster School of Business is currently not accepting post-baccalaureate student applications.

Foster School of Business Application

| Intended Start Quarter | Submit Application by: |

| Winter | October 5 |

***Note:** International Students are accepted only in autumn.

All access to the online business school application requires UW NetID authentication. Transfer students will be issued UW NetIDs upon completion of their UW admissions application.

MINIMUM ACADEMIC REQUIREMENTS

- **At least 60 transferable college credits** at the time of application.
- **A minimum 2.0 cumulative GPA** for all college credits **AND** all business course credits.

WRITING SKILLS ASSESSMENT (WSA)

All applicants must take the WSA. In the assessment session, students must complete two tasks: one persuasion task and one position task. The Foster School allows each applicant to take the WSA once per application period. Scores are valid for two years.

Pre-Application Courses

Pre-application courses must be complete with a decimal grade **before beginning application**:

ACCT& 201: Principles of Accounting I
ACCT& 202: Principles of Accounting II

ECON& 201: Microeconomics **OR**
ECON& 202: Macroeconomics

ENGL &101: Composition

MATH &148: Business Calculus **OR**
MATH &151: Calculus I

Pre-Admission Courses

In addition to the pre-application courses, the following courses **must be in-progress** at the moment that you click "apply" to Foster. (the end of spring quarter for autumn applicants or the end of autumn quarter for winter quarter applicants):

ACCT &203: Principles of Accounting III

ECON& 201: Microeconomics **AND**
ECON& 202: Macroeconomics

BUS 200: Introduction to Law **OR**
BUS& 201: Business Law

BUS 210: Business & Economic Statistics

Note: MATH& 146, which is equivalent to STAT 220 at UW, will no longer be accepted for admission unless taken prior to Winter 2018.

PERSONAL STATEMENT

Along with academics, the Foster School considers other factors when reviewing applications, including a required personal statement.
