

## Certificate of Accountancy – ATBACC45

Requirements Effective Fall 2026

### Program Planning Guide

**Program Description:** This certificate is designed for anyone who has a non-accounting bachelor's degree and is working toward meeting the accounting educational requirements of the Washington State CPA Examination. Additional courses are necessary to fulfill the requirements to sit for the exam. The courses in this certificate are not considered to be an official statement of acceptability by the Washington State Board of Accountancy. Students should consult the State Board's website for specific exam requirements. In addition, we strongly recommend that all CPA applicants complete a CPA review course to adequately prepare for the CPA Examination.

**Prerequisites:** Many of the classes have prerequisites. Prerequisites are those classes that prove eligibility for entry-level classes by having satisfied prior course work. Course work earned at other institutions must be unofficially evaluated or approved by a program advisor before registering. Courses in this certificate with pre-requisites are marked with an asterisk (\*). See catalog for more information.

**Certificate of Accountancy Entry requirements:** ACCT&201 and ACCT&202 with a grade of 2.0 or better. It is necessary that students have taken all prerequisite accounting courses within five years of the course dates.
