Required steps to apply for a Prerequisite Student Loan

- 1) Apply for financial aid by completing your 2020-2021 FAFSA (Free Application for Federal Student Aid) at www.fafsa.ed.gov
- 2) Submit a Prerequisite Loan request form to the Financial Aid office.
- 3) Complete online loan entrance counseling and sign a Master Promissory Note at www.studentaid.gov.
- 4) Submit a valid government issued ID to the Financial Aid office.
- 5) Provide list of required courses needed for admission into program signed by an academic advisor.

Important Information:

You must be enrolled in a minimum of six (6) credits that apply to the program you are seeking admission to. If you drop below six (6) eligible credits at any time, you will no longer be eligible for your loans. You must at <u>www.studentaid.gov</u> and inform the financial aid office of completion in

complete Exit Counseling immediately online at <u>www.studentaid.gov</u> and inform the financial aid office of completion in writing. Prerequisite loans are limited to one 12 consecutive month period in your lifetime.

You must meet North Seattle's satisfactory academic progress requirements to qualify and remain eligible for loan funds. Please review the North Seattle's satisfactory progress requirements online at https://northseattle.edu/financial-aid/satisfactory-progress

If you are a first time borrower, or have requested a one quarter loan, due to federal requirements some or all of your funds will be held a minimum of 30 days. **Plan to pay your tuition to cover your tuition and fees.**

Carefully determine how much you need to borrow. Only one (1) loan change request per quarter will be reviewed. Loan Change forms will only be accepted after the 5th week of the quarter in fall, winter and spring. No changes are allowed during summer.

North will always award Subsidized loan funds before awarding Unsubsidized loan funds. However some students may not be eligible to borrow Subsidized loans. Loan amounts are based on eligibility.
