

CRRSAA and ARP – Higher Education Emergency Relief Funds

North Seattle College received Higher Education Emergency Relief Fund (HEERF) funds under the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSSA) and American Rescue Plan (ARP), and will post the required information to this website and update every quarter.

North Seattle College is posting this information to comply with the reporting requirements listed below.

North Seattle College disbursed CRRSSA funding awards by both student application request and direct disbursements.

Awards by Student Request

The college provides students with two opportunities to apply for funding for 1) emergency expenses by completion of the general emergency assistance application located at <https://northseattle.edu/emergency-assistance-students> and 2) School related expenses; tuition/fee, textbooks and supplies, and general personal expenses by completion of the [CARES funding application](#).

Emergency expenses are generally capped at \$2000 for the first quarter and \$500 for subsequent quarters.

School related expenses include tuition and fees where expenses may be covered for quarterly tuition and fee amounts; textbook and supply support is \$314 per quarter based on the Financial Aid Cost of Attendance; personal expenses are \$500 per quarter, if requested. Student accounts were credited when requested by the student in the application, otherwise they were released as a refund to the student.

Direct Disbursements

Direct Disbursements of \$1500 were made to enrolled students with a zero EFC as indicated by their Financial Aid Application for fall quarter 2021 and winter 2022.

- (7) **Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.**

Student who received this targeted announcement were those with Pell Grant eligibility, enrolled in programs where eligibility is determined by receipt of public/state assistance, recipients of unemployment insurance, basic food recipients, students who stopped out during the pandemic, and those with unpaid tuition

The notice of the availability of funding is provided to students by several methods, including: posting in online course message boards, messages in Canvas, weekly student leadership bulletin, and by faculty and staff when working with students.
