Accomplishments:

Seven departments have completed and presented their reviews to the ISPR committee. Feedback from the committee has been shared with presenters. Reports, presentations, and process support materials can be found on the ISPR Canvas course. Presentations to date include:

Department needs identified to date:

Spring 2020

- Continuing Education
 - Training/professional development for CE instructors
 - Sustain current staffing to manage the evaluation process
 - Financial Aid
 - Referral process
 - Sustain current use of UA registration block, reminder emails, and use of "good job" letter
- LETS (Library, eLearning, Teaching & Learning Center, Student Media Center)
 - Library: Reference a 5th librarian; Circulation Either increase current PT classified to FT or hire another PT classified
 - ELearning: A Director, which will help to expand the capacity of the Instructional Designer
 - Teaching and Learning Center (TLC): More stipend funding for faculty
 - Student Media Center (SMC): Full work team PT help from a Library staff person; PT help from other faculty (e.g. like SLC and TLC); PT non - student hourly
- Office of Institutional Effectiveness
 - Means to access SPSS remotely
 - Sustain current staffing levels of 2.0 FTEs, Survey Monkey and SPSS licenses

Fall 2020

- Office of Equity, Diversity, & Inclusion
 - Sustain full time staff time, and maintain full staffing with an Associate Director, Office Assistant III, Pathways Navigator and EDI Navigator
 - Maintain Equity and Welcome Center budget in order to continue to staff our EDI Ambassador to Clear Sky UNEA Student Hourly
- Student Learning Center
 - Accounting & Business Learning Center: increase awareness about ABLC support services among Workforce Instruction faculty
 - Math & Science Learning Center: develop and implement new strategies more directly focused on serving under-represented student populations in STEM education
 - Page One Writing Center: coordinators will maintain open communication with English and Social Sciences faculty to continue to build course content and develop ENGL 197specific assessment tools
 - Student Learning Center Workshops no needs in this area
- Workforce Education Funding to train multiple employees in the use of Formstack
