## Data Dashboard Agreement

A small group of Pete Lortz, Aimee Brown, Stephanie Dykes, Kyle Whitcomb, and Jill Lane are working on a data use agreement to ensure data from course success dashboard is used in a positive and not punitive way for faculty learning. Pete Lortz shared the data use agreement draft with the group for feedback.

## Mock Course Success Dashboard and Training

Stephanie Dykes and Kyle Whitcomb shared the mock course success data dashboard. The purpose of the dashboard is to identify best practices for instruction and learning to pinpoint student needs, provide faculty meaningful data, and act as a valuable tool to facilitate faculty-driven discussions. Guiding Team reviewed a training of the dashboard put together by Stephanie Dykes. The training was intended to answer hypothetical questions, provide instructors data to help them achieve educational and career goals and identify student course success data. The information should be used to identify best practices in pedagogy to help our students achieve their goals, in program review and to drive awareness, thinking and discussions that lead to improvement and change. This dashboard is NOT meant to be used in a punitive way or to evaluate faculty performance.

- The ability to filter by student group (example: Running Start, Students of Color)
